


# **Wheeling Non-Project Water**

This is a simplified CAP System model that dynamically implements key provisions of the CAP Staff proposal for the wheeling of non-Project Water under sections 8.17 and 8.18 of the Master Repayment Contract. These include the "Certified Additional Annual System Delivery Capacity" calculation and implementation of the "Peak Suppression Facility" concept. The CAP system is represented in three sections: from Lake Havasu to Lake Pleasant; Lake Pleasant to Picacho Peak; and Picacho Peak to Tucson. Different combinations of Project and non-Project deliveries/requests can be selected using the up/down arrows. Efforts have been made to make realistic representations of delivery capacities and distribution, but results should be considered illustrative only, and not a reflection of actual operations or policy implementation.
